《中国对外经济贸易文告》(以下简称《文告》)的前身为《中华人民共和国对外贸易经济合作部文告》,创刊于1993年,2002年6月经国务院批准更名。《文告》汇集刊登全国人大、国务院、各地方和各部门已按现行规定公布的所有有关或影响货物贸易、服务贸易、与贸易有关的知识产权(TRIPS)和外汇管制的法律、法规及其它措施等相关信息,并作为我国政府向WTO及其成员通报咨询和WTO对我贸易政策审议的官方刊物。

同时《文告》还承担商务部公报的职能。根据《中华人民共和国立法法》的相关规定,在《文告》上公布的由商务部制定的有关国内外贸易和国际经济合作方面的规章文本为标准文本,具有法律效力。

《文告》是了解中国国内外贸易和国际经济合作相关法律、法规、规章和其他措施的官方指定刊物,由商务部办公厅负责编辑,每周出版1—2期,不固定页码,全年出版不超过80期。
